

Guidelines to Help Everyone Enjoy The Wilderness Fellowship Ministries (TWFM)

Please sign and date this form and mail, email, or bring it with you to The Wilderness.

(If you are the **leader** of a group or family planning to use TWFM, **you** are responsible to present this information to your group or family.) **All vehicles driven by your group must enter the property at 22000 Cty Rd M, Frederic, WI 54837**

All persons, families, or groups, must provide their own health and accident insurance when on The Wilderness Fellowship Ministries property or at an event sponsored by TWFM.

If you are unable to comply with all of our guidelines and policies, please speak to us **prior to your arrival.**

FOR YOUR SAFETY, AND THE SAFETY AND RESPECT OF OTHERS

1. NO alcohol or other drugs
2. NO fireworks of any kind
3. NO firearms of any kind (If you are licensed to carry, you must talk with Randy for approval to carry while here)
4. NO SMOKING or vaping in or near buildings. Smoking allowed in parking areas only.
5. NO pets or emotional support animals allowed in the buildings or on the grounds. *Exception: service dogs- please notify*
6. NO candles
7. We strongly encourage you to “unplug” from devices that detract from your retreat experience
8. Quiet time is from 10:00 p.m. to 6:00 a.m.

ARRIVALS & DEPARTURES

1. It is **VERY IMPORTANT** for us to know your arrival time, especially if you are arriving after our regular office hours. We have set aside a time to greet you and help you get settled into your cabin **at the time you told us you would be arriving.** **If you are going to be later than your scheduled arrival time, please let us know what time you will arrive.**
2. **YOU MUST SIGN IN AT THE OFFICE WHEN YOU ARRIVE, before going to your destination, even after office hours.** (For groups, it is expected that the leader(s) arrive with or before the group and will sign in for the group.)
3. Check out time is 12:00 noon (except Sundays/Holidays) unless special arrangements have been made with the office.
4. **Please take note of the cancellation/no show policy regarding the facility you reserved; it is in your confirmation email and posted on our website.**

VEHICLES

1. Always drive slowly on the grounds, stay on the main roads to your destination, and watch for children.
2. Please park in designated parking areas only. Please obey posted signs.
3. Please avoid unnecessary driving. Leave your vehicle parked once you arrive at your site if at all possible.
4. Do not park on the grass (exception: Lakeside Cabin, or designated overflow parking areas).

CARE & USE OF FACILITIES

1. Please retreat only in the cabin or campsite that you have reserved.
2. The showers / bathrooms in the FFRC are for use by FFRC guests only.
3. The Prayer Cabin Village Showers / bathrooms are for Prayer Cabin guests only.
4. You will be held responsible for paying the cost of repair or replacement of any Wilderness property damaged, lost or broken by your group.

ACTIVITIES

1. In the summer the beach is open. However, TWFM does not provide a lifeguard. Children must be accompanied by an adult.
2. **Modest swim apparel is required. No bikinis. Please use godly discretion.**
3. When using the boats, canoes, or other water equipment, persons under age 16 must wear a life jacket at all times.
4. When fishing, all Wisconsin fishing laws apply.
5. Swimming, boating, hiking, canoeing, water skiing, snow skiing, skating, and all other activities are done **AT YOUR OWN RISK. TWFM does not provide insurance for you. You and your group must assume this responsibility.**
